## Billing items and billing methods

#### **Billing items**

When you use RDS instances, in addition to the RDS instance fees, you must pay extra for certain functions. The following table lists the billing items and standards.

## **Billing methods**

RDS supports the following two billing methods.

Billing method	Description	Considerations

# Billing details for configuration change

You can change the configuration of your instance based on business requirements. The following table describes the configuration change and associated billing details.

Number of days from the upgrade date to the expiration date

If the number of days from the upgrade date to the expiration date is less than 365, the daily price of the instance after upgrade is equal to the monthly price. If the number of days is equal to or more than 365, the daily price of the instance after upgrade is equal to the annual price. For more information on the billing standard, see Pricing.

- The configuration change you select upon renewal within the contract period takes effect during the new billing cycle, and your instance is billed based on the new configuration and length of service time. For example, if a monthly subscription instance expires on June 20, 2017, and you renew the instance and

		upgrade the instance configuration on May 10, 2017, then the instance is renewed and upgraded on June 20, 2017.  - If you upgrade or downgrade the instance configuration when you renew the instance upon expiration, the instance is billed based on the new configuration and subscription period.

### Renewal

The following table provides billing information for RDS instance renewal.

Billing method	Renewal description
	- To avoid data loss in case you miss the renewal time, you can activate automatic renewal when you buy an instance.
	<ul> <li>You can renew the instance within the contract period or within 15 days after contract expiration.</li> </ul>
Subscription	<ul> <li>The renewed instance is billed based on the new configuration and length of service time you select during renewal. For more information about the billing standard, see Pricing.</li> </ul>
	- For more information about the renewal procedure, see Renewal.
Pay-As-You-Go	A Pay-As-You-Go instance is billed according to the actual usage time, so no renewal is required.

# **Expiration and overdue payment**

The following table lists the retention policies of RDS instance and data when the Subscription instance expires or when the payment of the Pay-As-You-Go instance is overdue.

Billing method	Retention policies of instance and data
Subscription	When the instance expires for 15 days, it is locked. When the instance is locked for 15 days, it is released, and all the data stored in the instance is deleted and cannot be recovered.

Pay-As-You-Go

- If you exceed the credit limit of your credit card to which your Alibaba Cloud account is bound, all the instances under this account will be in the status of overdue payment.
- When the payment of the instance is overdue, the instance will continiously run for 15 days and then be locked. When the instance is locked for 15 days and is still in the status of overdue payment, it will be released and all the data stored in the instance will also be deleted and cannot be recovered.

**Note:** When the RDS instance is locked, the application cannot access the instance and you cannot do any operation to the instance either. We recommend that you renew your Subscription instance in time and make sure not to exceed your credit limit to avoid the effects on your business.
